## *Summary*

- Function: To provide creative and technical skills supporting the development, operation, design, installation and maintenance of online learning multimedia content
- Scope: Coordinates, develops, implements, and facilitates the creation of technology-enhanced multimedia materials in support of mediated instruction in the online learning environment

## *Duties*

- Typical:
  1. Develops and edits multimedia based layouts, graphics, animation, video, sound and content for use in online learning.
  2. Creates, edits and updates online learning lessons using various content management systems
  3. Edits videos gathered from events, presentations, or special assignments
  4. Creates screen captures for online learning modules
  5. Conducts research necessary to remain current in instructional technology
  6. Organizes and manages long- and short-term projects involving multiple designers and programmers
  7. Creates product specifications and development plans with input from team members
  8. Instructs and /or trains end users for effective uses of instructional technology
  9. Communicates and collaborates with University instructors to determine appropriate media to support instructional goals

  1. Assists in the evaluation processes of online learning
  2. Recommends new purchases in multimedia equipment and instructional software
  3. Participates in brainstorming sessions by helping to inspire, assist, and clarify
